

RELEASE OF ALL CLAIMS

The undersigned wishes to participate in the "Basketball I.Q. Training **Academy"** and the undersigned agree that by executing this Release of All Claims, the undersigned for himself/herself, his/her heirs, dependents, executors, administrators, successors and assigns, and any similar persons or entities (hereinafter collectively referred to as "Releasors") now and in the future, has fully released and forever discharged, and by these presents does release and discharge, A Coach Is, Inc., and all of the parent, subsidiary and affiliated companies, partnerships and other entities of A Coach Is, Inc. and their respective owners, members, partners, shareholders, heirs, administrators, dependents, employees, agents, associates, executors. directors, officers, managers, lawyers, predecessors, successors, assigns and insurers, and each of them, and all persons acting by, through, under or in concert with them or any of them (hereinafter collectively referred to as "Releasees") from any and all manners of action, liabilities, obligations, liens, debts, damages, claims, suits, judgments, losses, costs, executions and demands (hereinafter collectively referred to as "Claims") of any kind, nature, and description, from the beginning of the world to and including the present date which Releasors have had, now have or hereafter can, shall or may have against Releasees, and each of them, including but not limited to, any and all past, present and future Claims for: (a) property loss or damage; (b) mental, nervous, emotional and physical disabilities and injuries to all parts of Releasee's person and body; and (c) loss of monetary and social support, comfort and sexual relations, arising out of, based upon, or in connection with "Basketball I.Q. Training Academy".

Releasors agree that if they, or any of them, hereafter commence, join in, or in any manner seek relief through any suit arising out of, based upon, or relating to any of the Claims released hereunder, or in any manner assert against Releasees, or any of them, any of the Claims released hereunder or arising out of or related thereto, then they, and each of them, will upon demand pay to Releasees, and each of them, in addition to any other damages caused to Releasees thereby, all attorney's fees incurred by Releasees in defending or otherwise responding to said suit or claim.

This Release is made in accordance with the laws of the State of California and shall be interpreted and enforced under and pursuant to the laws of that

State. Releasors understand that Section 1542 of the California Civil Code reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor".

Releasors understand and hereby waive the provisions of Section 1542 and declare that they know that they may have claims and damages including but not limited to, property losses and personal injuries, illnesses or diseases whether minor or serious, which they presently know nothing about and that, as to those claims and damages, they take their chances and also declare that they understand that the parties they are releasing would not have agreed to compromise their claim for any amount if this Release did not cover claims and damages and the results thereof which may not yet have manifested themselves or may be unknown to or unanticipated by Releasors at the present time.

Releasors understand, acknowledge and agree that the execution of this Release consummates a compromise of a disputed claim and is not to be construed as an admission of liability on the part of Releasees or any of them.

Releasors acknowledge that they have read and fully understand the terms, conditions and consequences of this Release and have signed it voluntarily and of their own free will and accord.
